**ENTRY FEES:** Dressage: \$20/class CT: \$55/division (\$100 for two consecutive div., same horse/rider) No refunds. Entries may be limited. To ease scheduling difficulties, each rider may ride up to a total of 4 classes only.

**AWARDS:** Dressage & CT: 8 Ribbons per division

**STARTING TIMES:** Will be mailed. Send SASE, please. Times not sent without SASE.

**STABLING: LIMITED** on Grounds... Reserve in advance-\$25 for 1 day/night beginning noon Fri, or \$40 for 2 nights. Tack stalls may be limited-first come first served.

**NON-STABLED HORSES:** \$5.00/horse non-stabling fee...included with entry

**DIRECTIONS:** I-65 to exit 80(Edinburg) W on SR252 to US31. Straight across 31 on to Hosptial Rd. 4 miles to Schoolhouse Rd. Turn right and go ½ mile to horse park. All stabling will be on grounds.

Camping fee through HHP.

**DRESSAGE TESTS:** CT: 2006 HT –AHSA TESTS Small, sand arena. DRESSAGE: 2007 VERSIONS –Small, sand arena may be used. Training Level and above may be in large arena.

**COMBINED TEST DIVISIONS:** Jump from lowest to highest level...you may enter two consecutive divisions

CT1. Green as Grass	USDF A WALK TROT	18" cross rails – no in and out – no time
CT2. Beginner	2006 Beg. Novice Test A	2' jumps – no in and out – no time
CT3. Pre Novice	2006 Beg. Novice Test B	2'6" jumps – no in and out – no time
CT4 Novice	2006 Novice Test A	2'11" jumps - 1 in and out – 300mpm
CT5 Training	2006 Training Test A	3'3" jumps – dbl, in and out – 325mpm
CT6 Preliminary	2006 Preliminary Test A	3'7" jumps-dbl and triple in and out 350mpm
